Hi Kay,

My updates (all good news!) for Round Valley are:

- 1. DOT staff set out traffic counters on Main St. and 162 last week to capture traffic counts prior to the installation of the speed bumps. We're in touch with Julia and will go out and set out the counters again after the speed bumps have been installed.
- 2. The upcoming work I mentioned last meeting comes out of grant funds we were awarded through the Highway Safety Improvement Program (HSIP). This winter we will be working on design and environmental, then right of way. We are planning on constructing a sidewalk/pathway along Crawford Rd from Bigger Lane to Foothill Blvd. Depending on environmental and right of way, construction would be in the summer of 2024 or 2025.
- 3. The next call for projects for the Caltrans Active Transportation Program (ATP) will be next March with applications likely due in June 2024. We applied for the Round Valley Safe Routes to School project in the last cycle but were not successful. We will be applying again next year. We have received feedback from Caltrans on ways to improve our application plus we have a virtual site visit planned with the ATP team next March to further improve our application. We will also be receiving assistance from MCOG with writing the application.

I think that's everything from my end for now. I don't think I'll be able to make the meeting tomorrow, but feel free to share my updates and check in with me for future meetings.
