Greetings Everyone-

I am pleased to announce that the new Caltrans District 1 website for making suggestions for safety enhancements on the state highway through the HM4 safety program is now available. We welcome your input. Please go the link below to provide your suggested safety enhancements by March 29th.

The HM4 Safety Pilot Program supports quick turn-around proactive safety enhancements. The HM4 Safety program has six focus areas including: bicyclist safety, pedestrian safety, run off road prevention, crossover collision prevention, wrong way driver prevention, and horizontal curve warnings. The HM4 safety program has several restrictions that largely limit available safety enhancements to signage, striping, pavement markings, and plastic devices. Significant safety enhancements are possible even with these limitations. Typical safety enhancements that were funded in the last cycle include high visibility cross walks, rapid flashing beacons, pedestrian signage, and wrong way driving prevention. The location of these previously funded safety enhancements is also shown on the website. A fact sheet and presentation are attached for additional information about the HM4 safety program.

Providing your suggestions is as easy, just follow these steps:

Step 1) click the "submit a suggestion" button on the bottom right side of the page.

Step 2) navigate to the location of interest on the state highway then click on the map to select the specific point location of interest. The orange boundary provides a rough guide showing the location of the state highway.

Step 3) fill out the details of your suggestion on the right side of the page. Simply identifying an issue is sufficient although you are welcome to also suggest a specific treatment type to enhance safety. We ask for your name and contact information so we can contact you if we have questions, but your contact information will remain confidential. Only your agency name will be publicly viewable.

Step 4) click "report it" at the bottom right of the page to save your suggestion.

Step 5) Repeat the process for each of your suggestions.
