2 1. Plaintiffs are scheduled to file their opposition to the Defendants Matthew
3 Kendall and County of Mendocino Motion to Dismiss Plaintiffs' Complaint (Doc. No. 20) on
4 July 12, 2025 ("Motion to Dismiss").

5 2. Plaintiffs intend to file a motion for summary judgment ("Summary Judgment
6 Motion") on or before the date of filing the Motion to Dismiss.

7 3. The deadlines for filing ADR Certification and to meet and confer regarding initial
8 disclosures, early settlement, ADR process selection, and discovery plan are July 8, 2025. (Doc. 5)

9 4. The deadlines to make initial disclosures and file a Joint Case Management
10 Conference Statement are July 22, 2025. (Doc. 5)

11 5. The Initial Case Management Conference is scheduled for July 29, 2025.

12 6. The above deadlines shall be extended by 30 days from the date the Court issues a
13 decision on the Motion to Dismiss and the Summary Judgment Motion, whichever comes last, or
14 on a day and at a time available to the Court.

15 7. The parties shall bear their own fees and costs.
